



The Story of a Pioneer

John Myers, who has lived in Valley township, east of Hutchinson for forty years, is one of the earliest settlers of this section. In an account of the early days, he writes:

"Something over forty years ago, while living in Illinois, I made up my mind to go west and grow up with the country. A boy friend of mine owned a good team of mules, and also had the western fever. So we rigged up our outfit and started for Kansas the first of September 1871. We made the trip in three weeks. Newton was the end of the Santa Fe at that time and I well remember the day we arrived there. On that date a gang of cowboys engaged in a gun fight on the streets of Newton and eight of their numbers were killed. I don't think anyone was ever brought to trial for the killing. The bones of the victims lie buried somewhere in Newton today. We came on to what is now the north end of the main street of Burrton and stopped in front of Father Day's place. He had the only house between Newton and Hutchinson except Lacey's dug-out this side of Little River. We went into camp and located some vacant land and filed on it at Augusta. In October we went to work grading on the Wichita branch of the Santa Fe, south of Newton. When that was finished we went to Hutchinson and spent the winter. In the spring of '72 the railroad was completed to Hutchinson. That spring I got a team and built a shanty on my claim and went to breaking sod. I raised some corn and that fall, after I had gathered it, I and several other boys went to Osage City and stripped coal all winter. I have my old pick lying around here yet. We made our board and some of us had enough left to pay our fare back home. In '74 we were visited by the grasshopper scourge which left desolation in its wake and drove many settlers back to the eastern states. 1875 was as fine a season as I ever saw. I raised 500 bushels of wheat that year and got \$1.12 1/2 per bushel for it. In '76 we had another raid of grasshoppers. They stayed longer this time and did lots of damage, but left our fall wheat all right. In '77 we had rain - floods of it and everything grew. I raised 1,150 bushels of wheat that year and got 93 cents for it. '78 was about the same - wet and a good crop about the same results except prices were not so good. During those years we had many bright prospects blasted by a few days or weeks of hot winds but when a bountiful year did come all those calamities were forgotten."



Pioneer Gets His Last Wish

Can't Comply With Request

Reno County Pioneer Wanted To Be Laid at Rest Here

Because of provision of the quarantine regulation forbidding it the body of Bradford P. Hanan, an old resident of Reno county, cannot be laid at rest by the side of his wife at Langdon as he had requested before death.

Mr. Hanan died at the National Soldiers Home at Leavenworth last week where he had been for two years. He was 82 years of age. His body was interred at the Home cemetery at Leavenworth, although it had been his request that he be buried in the Old Langdon cemetery and be given a Masonic burial.

Mr. Hanan located in Reno county in 1875 settling on a claim five miles west of Arlington. For years he was engaged in the nursery business at Arlington.

Remains of B. P. Hanan Laid at Rest Beside Wife

The body of B. P. Hanan, an old soldier of Reno county who died about three weeks ago at the soldiers home at Leavenworth, was laid at rest today beside his deceased wife in the Old Langdon cemetery.

When Mr. Hanan died there was a smallpox quarantine at the home and the body could not be brought here then. It was his request that he be buried beside his wife. The funeral occurred under Masonic auspices today.

The Hanan headstone contains information on Bradford, his first wife, Martha, and his mother, Polly Sullivan. A newspaper account from 1/26/1888 reports that Martha Hanan died after eating canned peaches believed to be poisoned from the cans.





Grand Army of the Republic

A fraternal organization composed of veterans of the Union Army. Founded April 6, 1866 in Decatur, Illinois by Benjamin F. Stephenson, M.D. The last member, Albert Woolson, died in 1956 at the age of 106 (some reports state 109). The G. A. R. is divided into departments at the state level and posts at the community level. The Kansas Department was organized in 1866 and reorganized in 1880.

G.A.R

Court Room, Court House

Hutchinson, KS, July 4, 1879

All old soldiers [after adjournment of the meeting of the soldiers] who wished to form a post G.A.R. met and organized by electing comrades H. Hartford, President and S. A. Atwood, Secretary. All who wish to form a Post G. A. R. were requested to sigh the roll. Almost the whole number signed, The Secretary was requested to procure the necessary papers to organize a Post. Meeting adjourned subject to call of President.

Courtroom, Court House

Hutchinson, KS, July 5, 1879

Meeting convened at call of President, at 8 p.m. with comrade H. Hartford, President and S. A. Atwood, Secretary. Minutes of last meeting read and approved. By unanimous consent it was agreed to establish Post of G. A. R. Each member was assessed 50 cents toward defraying expenses of organizing the Post. On motion, proceeding to elect officers for the Post G. A. R and the following comrades were elected to respective offices, to wit: Comrades S. B. Zimmerman, Post Com.; J. H. Leeman, Sen. V. Com.; J. McMurry, Jr. V. Com.; S. A. Atwood, Q. Master; F. L. Mintie, O. of day; J. A. Roosa, Jr. Adjutant; W. R. Truesdell, O. of Guard. By motion election of Chaplain Surgeon deferred. Secretary was instructed to write to A. G. of G. A. R., Leavenworth, Kansas, for papers and instructions. A vote of thanks tendered Comrade Brown, of Kansas City, for information given. Secretary instructed to furnish copy of proceedings to each of our county papers with request to publish. Each comrade requested to bring one recruit next meeting. After singing "John Brown's body lies moldering in the ground," adjourned to meet again Saturday evening, July 12, 1879. S. A. Atwood, Secretary. H. Hartford, President.





David Livingston and C. P. Van Hoozier Did Not Long Enjoy Liberty

David Livingston, who escaped from the reformatory on the night of July 6, was captured a few days ago at Bennett, Nebraska, while on his way to the home of his parents in Lincoln. He was brought back to the reformatory Saturday night by Officer Edw. Breuner.

Livingston had been a trusty and would have been eligible for parole this month if he had not made the break for liberty when he did. Livingston simply walked off early one evening, following the Rock Island through the sand hills to Medora. He was seen at that place by the station agent who telegraphed the authorities in Hutchinson, but Livingston caught an east bound train before he could be captured. He told Officer Breuner that he had been so homesick he could not resist the temptation to escape when opportunity offered.

C. P. Van Hoozier who was paroled three months ago was brought back to the reformatory Wednesday. Van Hoozier was paroled on account of ill health, but instead of going to Colorado to recover, as it was intended he should, he made things lively in the Mount Hope neighborhood. He was arrested Saturday at that place for gambling, etc., and the authorities at the reformatory notified of the broken parole.


Walnut Township

The first building was erected in the Spring of 1885. The thirty-two by forty foot building cost \$908.84 with all of the labor being donated. The pews and pulpit were constructed at this time. Before this families met in various homes and later in the Hodge and Centennial schoolhouses, alternating due to the distance. Isaac Zimmerman deeded the plot of ground where the present day church now stands.


Funerals



Prior to the first church building funerals were conducted in the home of Daniel Schmucker. The first funeral was that of Anna Schrock. She was buried, along with several others, in the cemetery site on the Jacob Miller farm. A burial site was also located on the John Yaggy farm south of Nickerson. After the church was built and a cemetery started all of the bodies were moved to the church cemetery.

The first burial in the new cemetery was that of Catharine Schrag [Grandmother Schrag], mother of Mrs. Albrecht and Mrs. Fliginger. The second was baby Eli Rediger, son of Mr. and Mrs. Christian Rediger. Rev. John Doetsch was the third burial.

Six Chairs for Mourners



There were six chairs for the mourners, but no one came to sit in them. Garner F. York, 56, was buried matter-of-factly Wednesday afternoon in the

crowded section of Eastside Cemetery set aside for indigents. Only a minister, a funeral director, his assistant, a News reporter, and a photographer, were at graveside. Four cemetery workers, dirty from the day's work, waited under a shade tree to lower the coffin. York died Monday afternoon in the city jail of what an autopsy showed to be far-advanced lung cancer with pneumonia complications. He crawled off a freight train in Hutchinson Saturday. No one knew where he was going or from where he came. No one claimed the body. A sister in Texas was too old and too ill. A brother, also a drifter, either couldn't be located or couldn't help. One person at the service might have been a relative. The minister, it was said, thought he was a cousin. The funeral home said the minister had never seen York and preferred not to be identified. York was buried in a wooden coffin. The cemetery workers lifted the coffin from the shiny white hearse and placed it in position over the grave. The only tombstones nearby were broken and wobbly. Grave markers were wooden crosses with names scrawled in black or yellow paint. Some graves were not marked at all. Earlier workers had lined six wooden chairs alongside the grave. No one sat down. The minister spoke a short prayer, read several brief Bible passages, and closed with a second prayer. The service ended in less than five minutes.


Maximum Allowed

County Welfare authorities agreed to pay \$300 for funeral expenses, the maximum allowed by state law. Welfare also will pay \$60 for cemetery expenses. York, according to an acquaintance in Carlsbad, Texas, and a sister, was never known to have a job. He was sitting against a building in the 200 block of West D when an officer spotted him Saturday.

Nathan H. Shepherd

Nathan Hampton Shepherd was born and lived in Tuscarawas County, Ohio, until middle life. He was a large farmer and dealer in stock, and was known in all the surrounding county. The family was large. His brothers and sisters still live and are influential citizens of that section of Ohio.

He moved to Harvey County, Kansas, in 1876, where he lived for three years, and then moved to this section of Reno County. He was the manager of the Thompson stock ranch, was one of the charter incorporators of the city of Sylvia and has ever, with abiding faith, maintained that there was no better section for success in life than was offered here for the man who was willing to work. Many a man who was discouraged and ready to leave would listen to his predictions of "better times to come," take new heart and courage that would make success possible. He was always prominent in every movement that would build up and advance the best interests of the community. He was a man of strong and decided convictions and one who had the courage at all times to defend his honest belief and, while others might not agree with him on political and social questions they gave him that respect and admiration that all will have for those who are honest and brave.

The death of "Uncle Nate, "as all familiar called him, though expected for many days, struck on the hearts and minds of all that a friend had gone, that one who was a familiar, genial companion would no more be met in his accustomed place or on the street. Perhaps no one in the community would be missed as he has been. For a year Uncle Nate was gradually failing. No certain disease seemed to prey on him, but a gradual giving way of the vital forces and each partial rally only left him weaker than before, but he had a will and vitality that was wonderful, for days when life seemed with him, but a "passing breath" he patiently waited, never complained, never expressed a regret, with a look of recognition to the loved ones and friends that surrounded his bed to the last, he gently and peacefully passed away, "and life's labor was done. "And may we, as did he, when life duties are done well, wrap the mantle of our good deeds around us and lie down to pleasant dreams."

Forty - five years ago Nathan H. Shepherd married Lucinda Mardias in Tuscarawas County, Ohio, who still survives him. In this long companionship together how many have been the joys, the triumphs, the hardships shared together and incidents to the early settlement of Kansas but through it all they have lived a life of faith that in the "great beyond" they would together enjoy a life of "bliss eternal". Aunt Cinda is left alone, but cherished by the love and affection her children and all who know her. Uncle Nathan died on the 19th day of October, aged 73 years. The surviving children are Mesdames May Thompson, and Dollie Smith, and John Shepherd of Sylvia, Kansas, James H. Shepherd of Hutchinson, Kansas, Mrs. Emma Turkee, of Valley township, and H. T. Shepherd of Kansas City, Missouri. All are prominent in the communities where they live and the example and character of their honored father lives in them.


